**Re: 2016 Eastern Canadian Artistic and T&T Championships**

**Date:** March 3, 2016

The 14<sup>th</sup> Eastern Canadian Gymnastics Championships are being hosted by Club de gymnastique Québec Performance and Gymnastique Québec and are being held at the Stade Telus in Quebec City from May 5-9, 2016. The competition schedule will be posted on the GNS website and forwarded to parents once it becomes available.

The Nova Scotia Provincial Artistic Teams will be announced following competition at the NS Provincial Championships, based on the Women's and Men's Program regulations. The Nova Scotia Provincial T&T Teams will be announced based on sanctioned competition results.

**In order for your child to be eligible for team selection, it is NECESSARY that you have the following information to your club by *date to be filled in by club***. Clubs must have this information to the Gymnastics Nova Scotia office by March 24<sup>th</sup>, 2016 for both Artistic Gymnastics and Trampoline and Tumbling. If your child does not make this team, your cheque will be returned to you at the Provincial Championships or through your club following Provincials.

### **Forms and Payment Required**

- A cheque for **\$453.00** made payable to **Gymnastics Nova Scotia** (this can be postdated to April 11<sup>th</sup>)
- **GNS Consent Form** (1 form attached - please ensure appropriate consent form for age)
- **GNS Medical form** (1 form attached)
- **Host Consent/Waiver Form** (1 form attached)
- **Fair Play Form** (1 form attached)

The above forms are also available on the GNS webpage under Events then Easterns Artistic or Easterns T&T. **Completed forms and payment are to be passed on to a designated person in your club by the date indicated above. If GNS does not receive these forms and payment at least one week prior to the Provincial Championships, the club will be fined and your child may not be eligible for team selection.** Clubs are responsible to collect all the information by the club deadline date and then pass it on to GNS as **one complete package** by the **GNS deadline date of March 24, 2016**. If forms are received after the deadline the club will receive a fine from GNS.

### **Team Travel Event**

This is a team travel event so athletes are expected to be with the Team NS delegation at all times during the trip. If an athlete needs to leave the delegation for an **approved reason**, the appropriate paperwork needs to be completed by the following dates:

- special travel requests for **extenuating circumstances only** – must be submitted to GNS by March 31st
- to leave the delegation for small amount of time during the trip for **an approved reason only** – paperwork must be submitted to GNS by April 29th.

### **COST BREAKDOWN**

#### **Transportation**

**\$170 per person** – includes travel to Quebec City and return transportation back to Halifax. The Gymnastics Nova Scotia group will travel via Ambassadors Bus lines and will depart the Metro Halifax area on the morning of Thursday, May 5<sup>th</sup>. Actual times and the pickup locations will be communicated as the event gets closer. The group will return on Monday, May 9<sup>th</sup> following the competition. Two rental vehicles are also booked in Quebec to transport small numbers if needed.

#### **Accommodations -**

**\$153 per athlete** – Nova Scotia participants will be staying at the Hotel Universel Quebec City on May 5, 6, 7, & 8th. This hotel is about an 8 minute walk to the competition venue. All judges will also be housed at the Hotel Universel Quebec City. **As per GNS Policy, all team members are required to stay with the team in the team venue.** The coaches and the GNS Program Committees will make the rooming assignments. Athletes will be the responsibility of the coaches and team support staff.

#### **Registration -**

**\$80.00** per athlete (includes closing athlete banquet on Sunday, May 8<sup>th</sup>)

#### **Cost Share Amount –**

**\$50.00** per athlete –amount helps fund expenses of team coaches, judges and support staff

#### **Meals -**

Meal cost is the responsibility of the individual. Please budget for the following meals:

- Thursday – lunch, supper and snacks for the bus
- Friday – breakfast, lunch, supper and snacks
- Saturday – breakfast, lunch, supper and snacks
- Sunday – breakfast, lunch, and snacks
- Monday - breakfast, lunch, supper and snacks for the bus

### **Uniforms -**

All athletes and coaches are required to wear the official GNS track jacket with black pants. For competition, girls are to have the new provincial leotard and boys are to have the provincial singlet with blue pants. Club coaches are responsible for ensuring that all **gymnasts from their club are outfitted properly**. **Payment for track jackets, girl's leotards, boy's singlets, pants and shorts will be made to your club and one cheque will be sent to GNS from the club. The actual prices for the team bodysuits, singlets and pants will be relayed to your club once they all arrive.**
